ANIMAL CONTROL AGREEMENT

No unit is allowed to house more than (2) DOMESTIC ANIMALS. Cat and dog owners MUST obtain a license and annual shots, as stipulated by Martin County, and a TAG MUST BE WORN BY CATS AND DOGS AT ALL TIMES. A Martin County license can be purchased at all Martin County Tax Collector Offices.

PROOF OF ANNUAL LICENSING AND SHOTS MUST BE SUBMITTED TO THE STHOA WITH THIS APPLICATION AND ENCLOSE (2) PICTURES OF EACH PET. ***(During the occupancy of your unit you will be responsible for updating this information yearly, as well)*.**

ALL DOGS MUST BE KEPT ON A LEASH AT ALL TIMES AND ARE NOT ALLOWED TO RUN FREE.

Dogs and cats are not allowed to be tied outside any unit, or left unattended on porches, patios, at the main entrance or outside the fence of your unit. All residents must pick up after pet waste immediately.

No resident shall keep, harbor, or maintain an animal, which barks or cries so as to disturb the peace and quiet of the neighbors.

Animals that roam will be subject to pick-up by animal control.

Pet Licenses

Per Martin County Ordinance #557, owners are required to have their cats and dogs vaccinated against rabies and obtain a Martin County Animal License. A new license tag must be purchased each year for all cat and dog pets, regardless if the animal has a one year or three year vaccination. To obtain a pet license, bring a copy of a current rabies vaccination certificate issued by the veterinarian.

Per Martin County Ordinance #557 Sec.4.35

- When the dog or cat reaches the age of three (3) months
- Within thirty (30) calendar days of acquiring the dog or cat
- Within thirty (30) calendar days of entering Martin County
- Within thirty (30) calendar days of license tag expiration
- Within thirty (30) calendar days after rabies vaccination

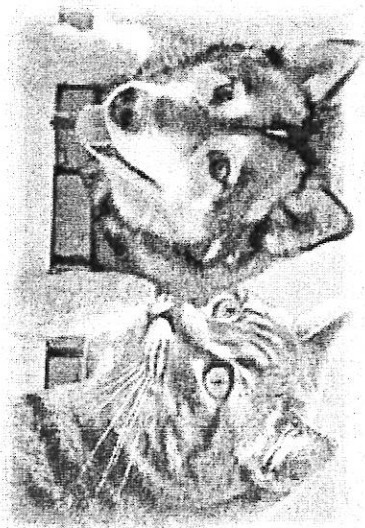
Fees

- **Sterilized Pets**
 - With Microchip = \$10.00
 - Without Microchip = \$20.00
- **Unsterilized Pets with or without microchip** \$75.00
- **Dangerous Dog license:** \$60.00
- **Replacement Tags:** \$2.00
